Subject: <u>Schedule of Parking Citation Penalties (Continued from November 9,</u>

<u>2020)</u>

<u>RECOMMENDED ACTION</u>: 1) Conduct the Public Hearing; 2) Adopt Resolution No. 20-59 amending the City's Schedule of Parking Citation Penalties, repealing Resolution No. 15-09, and finding the action to be exempt from the California Environmental Quality Act; and 3) Direct the Public Safety Commission to review the Schedule of Parking Citation Penalties annually, or at another frequency determined by the City Council.

<u>FISCAL IMPACT:</u> In Fiscal Year 2019-2020, the City received approximately \$1.2 million in revenue from parking citations (unaudited). Based on the citations revenue received in Fiscal Year 2019-2020, if the new fees are approved, the City could potentially receive between \$100,000 to \$200,000 in additional revenue.

WORK PLAN: This item was not included in the Adopted Work Plan for Fiscal Year 2020-2021.

<u>DISCUSSION</u>: On November 9, 2020, the Council continued this item.

Malibu Municipal Code Section 10.04.010 adopts Los Angeles County Title 15 (Vehicles and Traffic) as the traffic ordinance for the City. By resolution, the City Council establishes a Parking Penalty Schedule (Schedule) for violations of that ordinance. The Schedule indicates the related Los Angeles County Code Section and, where appropriate, the California Vehicle Code as reference. The last time the Schedule was updated was on January 21, 2015 when the City Council adopted Resolution No. 15-09.

At its Regular meetings on September 4, 2020 and October 7, 2020, the Public Safety Commission reviewed the Schedule to consider a recommendation to the City Council regarding adjustments to be made in order for the City's Schedule to be consistent with Los Angeles County Code Chapter 15.200, Schedule of Civil Penalties and Additional

Assessments for Parking Violations, and California Vehicle Code Division 11, Rules of the Road.

The Commission Chair and Vice Chair researched penalties imposed by other cities, including member cities in the Las Virgenes-Malibu Council of Governments and other coastal cities. The attached Parking Fine Comparison spreadsheet (Attachment 2) details fines currently imposed by the City compared to penalties imposed by the Cities of Calabasas, Santa Monica, Manhattan Beach and Laguna Beach.

The Commission voted to make a recommendation to the Council that it revise the City's Schedule of Parking Citation Penalties as follows:

It was discussed that current rates often do not act as a deterrent to motorists choosing to park illegally. The suggested increases range from \$5 to \$20 with no changes recommended for any penalties currently over \$100.

The Commission's recommendation also included the addition of a new fee of \$73.00 for Parking at Red Curb (Code 15.20.070); however, staff subsequently confirmed with the Sheriff's Department that the addition was unnecessary because that violation was cited as a Failure to Obey Signs already included in the Schedule. Lastly, the Commission suggested that it be directed to review the Schedule annually or at another frequency determined by the Council.

RESOLUTION NO. 20-59

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MALIBU AMENDING THE CITY'S SCHEDULE OF PARKING CITATION PENALTIES, REPEALING RESOLUTION NO. 15-09, AND FINDING THE ACTION TO BE EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

The City Council of the City of Malibu does hereby find, order and resolve as follows:

SECTION 1. Recitals.

- A. Pursuant to California Vehicle Code section 40203.5, Malibu Municipal Code section 10.12.060 states that parking penalties shall be established by resolution of the City. These penalties are detailed in the City's Parking Penalty Schedule (Schedule) for violations of that ordinance. The Schedule indicates the related Los Angeles County Code Section and, where appropriate, the California Vehicle Code as referenced.
- B. At the recommendation of the City Council Administration and Finance (A&F) Subcommittee, the City Council adopted Resolution No. 15-09 on January 21, 2015, amending the City's Schedule, which was included as part of the Resolution.
- C. At its Regular meetings on September 4, 2020, and October 7, 2020, the Public Safety Commission reviewed the Schedule and researched penalties imposed by other cities, including member cities in the Las Virgenes-Malibu Council of Governments and other coastal cities.
- D. It was discussed that current rates often do not act as a deterrent to motorists choosing to park illegally and/or do not reflect the penalties imposed by other issuing agencies in Los Angeles County, so the Commission suggested certain fines be increased from \$5 to \$20 except for those penalties that are currently over \$100.
- E. The Commission recommended that the Council approve the following revisions to the Schedule:

SECTION 2. The City of Malibu hereby rescinds Resolution No. 15-09.

<u>SECTION 3.</u> The Schedule of Parking Citation Penalties attached hereto as Exhibit 1 is hereby adopted.

<u>SECTION 4.</u> City staff has determined that the changes to the City's Schedule of Parking Citation Penalties are statutorily exempt from environmental review under California Public Resources Code section 21080(b)(8) and California Environmental Quality Act implementing guidelines, Title 14 of the California Code of Regulations section 15273 and section 15061(b)(3).

<u>SECTION 5.</u> This resolution shall become effective immediately upon its passage and adoption, except that the penalties set forth in the official Base and Late Fine Schedule for Parking Violations shall take effect as citations are printed giving notice of the new fine amounts.

<u>SECTION 6.</u> The City Clerk shall certify adoption of this resolution and shall cause the same to be processed in the manner provided by law.
