Subject: City Council Appointments to City Commissions and Committees

RECOMMENDED ACTION:

- 1) Mayor Pro Tem Grisanti and Councilmembers Silverstein and Uhring to each make an appointment to the Cultural Arts Commission, Parks and Recreation Commission, Planning Commission, Public Safety Commission, Public Works Commission, and Wastewater Advisory Committee;
- 2) Councilmember Farrer to make an appointment to the Public Works Commission;
- 3) Council may appoint or affirm appointments of an ex officio member to the Cultural Arts Commission, Parks and Recreation Commission, and Public Safety Commission;
- 4) Council to appoint or affirm two at-large appointments to the Wastewater Advisory Committee;
- 5) Council to appoint or affirm five appointments and two alternate appointments to the Building Board of Appeals; and
- 6) Council to defer appointment of members to the Mobilehome Park Rent Stabilization Commission until such a time as it is necessary for the Commission to meet.

FISCAL IMPACT: There is no fiscal impact associated with the recommended action.

WORK PLAN: This item was not included in the Adopted Work Plan for Fiscal Year 2020-2021. This is part of normal staff operations.

DISCUSSION: Pursuant to Malibu Municipal Code (MMC) Title 2, Council appointments to various City Commissions run concurrently with the appointing Councilmember's term. Therefore, following the election, each newly elected Councilmember appoints Commission members. Individuals may serve on only one commission, board, or committee at any given time, in accordance with Council Policy No. 48 – Opportunity to Serve (adopted February 25, 2013).

Appointments to the Harry Barovsky Memorial Youth Commission are at-large, run for one year at a time, and last occurred at the June 8, 2020 City Council meeting.

Following are the existing appointments on City Commissions. Former Councilmembers Mullen, Peak, and Wagner’s appointments continue until replaced or reappointed and are listed only for reference. Staff verified that all applications attached to the staff report meet various criteria for appointment.

Cultural Arts Commission:

The Cultural Arts Commission differs from other City Council Commissions in that MMC Section 2.26.030 states that an interview process shall precede appointments. Any applicants have been invited to attend this meeting, so they may be called on to answer questions the Council may have pursuant to the interview requirement outlined in the MMC. Pursuant to MMC Section 2.26.020, a member of the Cultural Arts Commission shall be a resident of the City. The City Council may appoint one ex officio member who lives outside the City limits but within the 90265-zip code area and shall not have a vote on the Commission.

Peter C. Jones is a fine art & publication consultant, author, photographer and documentary filmmaker. In the course of thirty-five years, he has organized more than 100 exhibitions throughout the United States and Europe and produced more than 70 books. Since 1984, he has represented the fine art photographs of Josef Breitenbach, originating 29 one-person exhibitions and 11 books.

His photographs are represented by KMR Arts which mounted two one-person exhibitions, each with a catalogue. Benrubi Gallery mounted two one-person exhibitions in New York including one about his book Sweep Out Cottage (Nazraeli Press). Jungle Stories will be published in 2021 accompanied by his third one-person exhibition at KMR Arts.

He is the author of The Changing Face of America (Prentice Hall) and his photographs are included in the collections of the Metropolitan Museum of Art, The Museum of Modern Art, LACMA, The High Museum, The Hermes Collection and The Cleveland Clinic Collection.

His first documentary, A Rising Tide of Silence, about the life and world reach of Father Thomas Keating premiered at the 2013 Aspen Film Festival and won the Audience Choice Award. His second film, From The Mind To The Heart, was released in 2019. Both films are on Amazon Prime. He has lectured about Thomas Keating at Harvard, MIT and Pepperdine.

In my brief tenure as a Commissioner of the Cultural Arts Commission I have been impressed with the directions we have taken and the assistance of the staff.


I am especially pleased to have been involved with establishing Poets Path in Legacy Park celebrating Malibu's Poet Laureates as a permanent home for their Poet's Stones which are now easily accessible to everyone in an elegant setting.

I am particularly proud of our open group exhibition program that opened in the spring of 2019 with the two part exhibition about the November 2018 Woolsey Fire: Radical Beauty, Malibu Rising that helped unite our community in the aftermath of that catastrophe.

What has been missing is one of my passions: live music which has been in a state of cultural paralysis. With the advent of the Covid vaccine, I am hopeful that we can find ways to encourage live music to return Malibu.

Walt Whitman said it best in his poem, I Hear America Singing. First published in Leaves of Grass in 1860 on the eve of the Civil War, it presented Americans – mechanics, carpenters, shoemakers, mothers, young wives and girls "each singing what belongs to him or her and none else." In this time of darkness and frustration, music can fill our community with light.


