MEETING CALL TO ORDER

Mayor Grisanti called the meeting to order at 4:18 p.m.

REGULAR SESSION CALL TO ORDER

Mayor Grisanti called the meeting to order at 5:05 p.m.

PLEDGE OF ALLEGIANCE

Mayor Grisanti led the Pledge of Allegiance.

CLOSED SESSION REPORT

Interim City Attorney Cotti reported that the meeting convened at 4:18 p.m., after which time the City Council recessed to a Closed Session pursuant to Government Code Sections 54956.9(d)(2) and 54957, with all Councilmembers present. He stated the Council took no reportable action.

APPROVAL OF AGENDA

MOTION Councilmember Farrer moved, and Mayor Pro Tem Silverstein a motion to approve the agenda. The question was called, and the motion carried unanimously.

REPORT ON POSTING OF AGENDA

Acting City Clerk Pettijohn reported that the agenda for the meeting was properly posted on July 19, 2021, with the amended agenda posted on July 20, 2021.

ITEM 1 ORDINANCES AND PUBLIC HEARINGS

A. <u>Nuisance Abatement</u>

Recommended Action: 1) After the City Attorney reads the title, introduce on first reading Ordinance No. 490 amending Chapter 8.28 (Nuisance Abatement) of Title 8 of the Malibu Municipal Code and finding the same exempt from the provisions of the California Environmental Quality Act; and 2) Direct staff to schedule second

reading and adoption of Ordinance No. 490 for the August 9, 2021 Regular City Council Meeting.

Public Safety Manager Dueñas presented the staff report.

Mayor Grisanti opened the floor for public comment. As there were no speakers present, Mayor Grisanti returned the matter to the table for discussion.

The Council discussed the item and directed questions to staff.

MOTION Mayor Pro Tem Silverstein moved, and Councilmember Pierson seconded a motion to: 1) introduce on first reading Ordinance No. 490, as amended to: a) replace wildfire with fire, b) add "vacant land" after undeveloped land, c) revise Malibu Municipal Code (MMC) Section 8.28.100(C) to include "property owners and persons in legal possession of the property are jointly and severally liable", and d) clarify that MMC Section 8.28.100 will be applied when there is insufficient time to follow the administrative process described in MMC Section 8.28.050, amending Chapter 8.28 (Nuisance Abatement) of Title 8 of the Malibu Municipal Code, and finding the same exempt from the provisions of the California Environmental Quality Act; and 2) direct staff to schedule second reading and adoption of Ordinance No. 490 for the August 9, 2021 Regular City Council Meeting

Interim City Attorney Cotti read the title of the ordinance.

The question was called, and the motion carried unanimously.

ITEM 2 NEW BUSINESS

- A. <u>Establishing a Homelessness Task Force</u>
 - Recommended Action: 1) Adopt Resolution No. 21-43 establishing a Homelessness Task Force to address issues related to homelessness; 2) Consider waiving City Council Policy 48 that limits individuals to serving on one commission, committee, or board; 3) Each Councilmember to appoint two members to the Homelessness Task Force; and 4) Provide direction to staff.

Public Safety Manager Dueñas presented the staff report.

Mayor Grisanti opened the floor for public comment.

As there were no other speakers present, Mayor Grisanti returned the matter to the table for discussion.

The Council discussed the item and made appointments.

Mayor Grisanti appointed Ian Roven and Terry Davis.

MOTION Mayor Pro Tem Silverstein moved, and Councilmember Uhring seconded a motion to: 1) adopt Resolution No. 21-43, as amended to revise Section 3 to add "develop a robust public engagement and outreach plan to obtain community input on proposed strategies to protect the health, safety and welfare of the community from the dangers of homelessness and provide assistance to Malibu residents experiencing homelessness," establishing a Homelessness Task Force to address issues related to homelessness; and 2) waive City Council Policy 48 that limits individuals to serving on one commission, committee, or board. The question was called, and the motion carried unanimously.
