Subject:	Amendment to Professional Services Agreement with PrimeGov	

<u>RECOMMENDED ACTION:</u> Authorize the Mayor to execute Amendment No. 1 to Professional Services Agreement with PrimeGov for certain projects relating to the live cast streaming of public meetings, live meeting management, and virtual public meeting capabilities in the amount of approximately \$15,000.

<u>FISCAL IMPACT</u>: No additional appropriation is required. Funding for this agreement was included in the Adopted Budget for Fiscal Year 2021-2022 in Account No. 100-7007-5100 (Professional Services).

<u>WORK PLAN</u>: This item was not included in the Adopted Work Plan for Fiscal Year 2021-2022. This project is part of normal staff operations.

<u>DISCUSSION:</u> As a result of the COVID-19 pandemic and in accordance with emergency orders in place at the time, in March 2020 the City suspended in-person City Council, Commission, Committee, and Board meetings and transitioned to virtual meetings. The City entered into an agreement with PrimeGov to build and support a virtual public meeting platform.

The City continues to conduct virtual meetings in accordance with AB 361 using the PrimeGov platform. As the COVID-19 pandemic is ongoing and it is uncertain when the City will transition to in-person or hybrid meetings, or if changes in the emergency conditions after that transition could require a return to virtual meetings, staff recommends extending the term of the agreement one year. The compensation for services reflects a 5% increase in the annual fee.

AMENDMENT NO. 1 TO AGREEMENT

THIS AMENDMENT NO. 1 TO AGREEMENT is made and entered in the City of Malibu on June 13, 2022, by and between the CITY OF MALIBU, hereinafter referred to as City, and PrimeGov, hereinafter referred to as Consultant.

The City and the Consultant agree as follows:

<u>RECITALS</u>

A. On June 1, 2020, the City entered into an Agreement with Consultant for consulting services for certain projects relating to the live cast streaming of public meetings, minutes and live meeting management, virtual public meeting capabilities and related services offered by Consultant (the "Agreement").

B. The City desires to amend the Agreement to extend the term of the agreement and amend the cost schedule.

NOW THEREFORE, in consideration of their mutual promises, obligations and covenants hereinafter contained, the parties hereto agree as follows:

- 1. Section 2.0 Term of Agreement, of the Agreement, is hereby extended to June 1, 2023.
- 2. Section 4.0 Compensation for Services, of the Agreement, is hereby amended as set forth in Exhibit A attached hereto.
- 3. The Parties agree that this Amendment will be considered signed when the signature of a party is delivered physically or by facsimile transmission or scanned and delivered via electronic mail. Such facsimile or electronic mail copies will be treated in all respects as having the same effect as an original signature.
- 4. All terms and conditions of the Agreement not amended by this Amendment No. 1 remain in full force and effect.

This Agreement is executed on ______, at Malibu, California, and effective as of June 1, 2022.
