Subject: <u>Amendment to Professional Services Agreement with Yunex LLC</u>

<u>RECOMMENDED ACTION:</u> Authorize the Mayor to execute Amendment No. 1 to the Professional Services Agreement with Yunex LLC in the amount of \$25,000 for a total not to exceed \$49,500 for traffic signal maintenance services and extend the term of the agreement for one year.

<u>FISCAL IMPACT:</u> No additional appropriation is required. Funding for this amendment was included in the Adopted Budget for Fiscal Year 2022-2023 in Account Nos. 100-3001-5124 and 100-3001-7800, in the Street Maintenance program.

<u>WORK PLAN:</u> This item was included as Item #8.D in the Adopted Work Plan for Fiscal Year 2022-2023.

<u>DISCUSSION:</u> On September 1, 2021, the City entered into an agreement with Yunex LLC, to perform traffic signal maintenance services for a period of one year for a not to exceed amount of \$24,500.

The City has three intersections controlled by traffic signals located along Civic Center Way at Malibu Canyon Road/Seaver Drive, at Winter Canyon Road, and at Webb Way/Stuart Ranch Road intersection, respectfully. In addition to the traffic signals, the City maintains existing flashing beacons and speed advisory feedback signs installed throughout the City.

The original agreement with Yunex LLC was for \$24,500, and includes the maintenance of the traffic signals, flashing beacons and the speed advisory feedback signs. The

agreement also includes the miscellaneous repairs of the traffic signals, flashing beacons, and speed advisory feedback signs. The proposed amendment will extend the term of the agreement one year and will increase the compensation for the annual maintenance and cost for any minor repairs of these facilities. The amendment will also include the replacement of damaged speed advisory feedback signs. Yunex LLC has performed very well during the term of its agreement.

Staff recommends executing Amendment No. 1 to extend the existing term of the agreement for one year to expire June 30, 2023, and to increase the total compensation to \$49,500 for the annual maintenance and repairs of the City's traffic control facilities.

AMENDMENT NO. 1 TO AGREEMENT

THIS AMENDMENT NO. 1 TO AGREEMENT is made and entered in the City of Malibu on September 12, 2022 by and between the CITY OF MALIBU, hereinafter referred to as City, and Yunex LLC, hereinafter referred to as Consultant.

The City and the Consultant agree as follows:

RECITALS

- A. On September 1, 2021, the City entered into an Agreement with Consultant for traffic signal maintenance (the "Agreement").
- B. The City desires to amend the Agreement to extend the term and compensation for services of the agreement. The Consultant has submitted a proposal for this purpose that is acceptable to the City.

NOW THEREFORE, in consideration of their mutual promises, obligations and covenants hereinafter contained, the parties hereto agree as follows:

- 1. Section 2.0 Term of Agreement, of the Agreement, is hereby extended to June 30, 2023.
- 2. Section 4.0 Compensation for Services, of the Agreement, is hereby amended to increase from \$24,500 to a not to exceed amount of \$49,500.
- 3. The Parties agree that this Amendment will be considered signed when the signature of a party is delivered physically or by facsimile transmission or scanned and delivered via electronic mail. Such facsimile or electronic mail copies will be treated in all respects as having the same effect as an original signature.
- 4. All terms and conditions of the Agreement not amended by this Amendment No. 1 remain in full force and effect.
