<u>RECOMMENDED ACTION:</u> Adopt Resolution No. 22-46 reciting the facts of the General Municipal Election held on November 8, 2022 and declaring the result and such other matters as provided by law.

FISCAL IMPACT: There is no fiscal impact associated with the recommended action.

<u>WORK PLAN</u>: This item was not included in the Adopted Work Plan for Fiscal Year 2022-2023. This is part of normal staff operations.

<u>DISCUSSION:</u> The election was consolidated and conducted by the Los Angeles Registrar Recorder/County Clerk (RR/CC). On December 7, 2022, the City received from the RR/CC the Official Canvass Certificate and Official Statement of Votes Cast by Precinct for the City of Malibu.

RESOLUTION NO. 22-46

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MALIBU RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 8, 2022 AND DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

The City Council of the City of Malibu does hereby find, order and resolve as follows:

SECTION 1. Recitals.

- A. A General Municipal Election was held and conducted in the City of Malibu on Tuesday, November 8, 2022, as required by law.
- B. Notice of the election was given in time, form and manner as provided by law. Voting precincts/voting centers were properly established. Election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities.
- C. The Los Angeles County Election Department canvassed the returns of the election and has certified the results to the City Council. The results are hereby received, attached and made a part hereof as Exhibit A.

<u>SECTION 2</u>. The whole number of ballots cast in the City precincts/voting centers except vote by mail voter ballots and provisional ballots was 1,226, and the whole number of vote by mail voter ballots cast in the City was 3,884, making a total of 5,110 ballots cast in the City.

<u>SECTION 3</u>. The names of the persons voted for at the election for Member of the City Council are as follows:

Marianne Riggins Ryan Embree Jimy Tallal Bill Sampson Doug Stewart Hap Henry Jason Herz

SECTION 4. The measure voted on at the election (Measure MC) is as follows:

To support such city services as public safety, crime and fire prevention, addressing homelessness, keeping public areas safe and clean, preventing speeding and reckless driving, protecting coastal waters and beaches from pollution, preserving natural areas, supporting local businesses, and other general city services; shall a measure be adopted	YES	
establishing a 1/2¢ transactions and use (sales) tax providing approximately \$3,000,000 annually until ended by voters, requiring public spending disclosures and local control of funds?	NO	

<u>SECTION 5</u>. The number of votes given at each precinct/voting center and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit A.

<u>SECTION 6</u>. The number of votes given at each precinct/voting center and the number of votes given in the City for and against Measure MC were as listed in Exhibit A.

<u>SECTION 7</u>. The City Council does declare and determine Doug Stewart and Marianne Riggins were elected as Members of the City Council for the full term of four years.

<u>SECTION 8</u>. As a result of the election, a majority of the voters voting on Measure MC, relating to establishing a $1/2\phi$ transactions and use (sales) tax, did vote in favor of it, and that the measure was carried and shall be deemed adopted and ratified.

<u>SECTION 9</u>. The City Clerk shall enter on the records of the City Council of the City of Malibu, a statement of the result of the election, showing: 1) the whole number of ballots cast in the City; 2) the names of the persons voted for; 3) the offices to which each person was voted for; 4) the measure voted upon; 5) the number of votes given at each precinct/voting center to each person, and for and against the measure; and 6) the total number of votes given to each person, and for and against each measure.

<u>SECTION 10</u>. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

<u>SECTION 11.</u> The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
