Subject: <u>Amendment to Professional Services Agreement with NextRequest</u>

<u>RECOMMENDED ACTION:</u> Authorize the Mayor to execute Amendment No. 1 to Professional Services Agreement with NextRequest for a platform through which the City may manage public records requests.

<u>FISCAL IMPACT:</u> No additional appropriation is required. Funding for this agreement/project is included in the Adopted Budget for Fiscal Year 2022-2023 in Account No. 100-7007-5100 (Professional Services).

<u>WORK PLAN:</u> This item was included as item #6.b. in the Adopted Work Plan for Fiscal Year 2022-2023.

<u>DISCUSSION:</u> The City receives over 600 public records requests in a typical year and requires a software system to manage tracking and responding to requests. The City began using NextRequest in 2020 and the system has worked well for staff and the public. This amendment extends the term of the current agreement, entered into on March 1, 2022, two years and accounts for a 5% yearly increase in costs. The cost of services for the next year will be \$13,643.44.

AMENDMENT NO. 1 TO AGREEMENT

THIS AMENDMENT NO. 1 TO AGREEMENT is made and entered in the City of Malibu on February 27, 2023, by and between the CITY OF MALIBU, hereinafter referred to as City, and NextRequest, hereinafter referred to as Consultant.

The City and the Consultant agree as follows:

RECITALS

- A. On March 1, 2022, the City entered into an Agreement with Consultant for Software-as-a-Service (SaaS) platform through which the City may manage public records requests (the "Agreement").
- B. The City desires to amend the Agreement to extend the term of the agreement and increase the compensation for services, and Consultant has submitted a proposal for this purpose that is acceptable to the City.

NOW THEREFORE, in consideration of their mutual promises, obligations and covenants hereinafter contained, the parties hereto agree as follows:

- 1. Section 2.0 Term of Agreement, of the Agreement, is hereby extended to March 1, 2025.
- 2. Section 4.0 Compensation for Services, of the Agreement, is hereby amended to allow the compensation as set forth in Exhibit A attached hereto, which includes a 5% yearly increase for use of the NextRequest Records Request Management Module.
- 3. The Parties agree that this Amendment will be considered signed when the signature of a party is delivered physically or by facsimile transmission or scanned and delivered via electronic mail. Such facsimile or electronic mail copies will be treated in all respects as having the same effect as an original signature.
- 4. All terms and conditions of the Agreement not amended by this Amendment No. 1 remain in full force and effect.
