RECOMMENDED ACTION: Adopt Resolution No. 24-63 reciting the facts of the General Municipal Election held on November 5, 2024 and declaring the result and such other matters as provided by law.

STRATEGIC PRIORITY: This item is part of the day-to-day operations identified in the Adopted FY 2024-25 Strategic Priority Project List.

DISCUSSION: A General Municipal Election was held in the City of Malibu on Tuesday, November 5, 2024, consolidated with the Statewide General Election for the purposes of election of three City Councilmembers. The election was conducted by the Los Angeles Registrar Recorder/County Clerk (RR/CC). On December 4, 2024, the City received from the RR/CC the Official Canvass Certificate and Official Statement of Votes Cast by Precinct for the City of Malibu. The results are attached as Exhibit A to Resolution No. 24-63.

As a result of the election, the following candidates were each elected to City Council for a term of four years:

- Bruce Lee Silverstein
- Steve Uhring
- Haylynn Conrad

RESOLUTION NO. 24-63

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MALIBU RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2024 AND DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

The City Council of the City of Malibu does hereby find, order and resolve as follows:

SECTION 1. Recitals.

- A. A General Municipal Election was held and conducted in the City of Malibu on Tuesday, November 5, 2024, as required by law.
- B. Notice of the election was given in time, form and manner as provided by law. Voting precincts were properly established. Election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities.
- C. The Los Angeles County Election Department canvassed the returns of the election and has certified the results to the City Council. The results are hereby received, attached and made a part hereof as Exhibit A.

SECTION 2. The whole number of ballots cast in the precincts including vote-by-mail ballots and provisional ballots are detailed in the Official Canvass attached as Exhibit A.

SECTION 3. The names of the persons voted for at the election for Member of the City Council are as follows:

SECTION 4. The number of votes given in each precinct and the number of votes cast in the City for each of the persons above-named for the respective offices for which the persons were candidates are set forth in Exhibit A.

SECTION 5. The City Council does declare and determine that as a result of the election Bruce Lee Silverstein, Steve Uhring, and Haylynn Conrad were elected as Members of the City Council for the full term of four years.

SECTION 6. The City Clerk shall enter on the records of the City Council of the City of Malibu, a statement of the result of the election, showing: 1) the whole number of ballots cast in the City; 2) the names of the persons voted for; 3) the offices to which each person was voted for; 4) the number of votes given in each precinct to each person; and 5) the total number of votes given to each person.

SECTION 7. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 8. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

SECTION 9. Severability. If any section, subsection, subdivision, sentence, or clause or phrase in this Resolution or any part thereof is for any reason held to be unconstitutional, invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Resolution or any part thereof. The City Council hereby declares that it would have adopted each section irrespective of the fact that any one or more subsections, subdivisions, sentences, clauses, or phrases are declared unconstitutional, invalid, or ineffective.
